I am fully aware of the hazards and accept all risks associated with flying activities. I hereby certify that I do not suffer from any physical infirmity or chronic illness including, but not limited tohearing problems or vision problems which would affect my ability to engage in flying activities. I furthercertify that I am not on any medication and have not taken any alcoholic beverages or drugs within the last 24 hours. I also recognise that it is against the Events and BAF rules undregulations to take either alcohol or drugs before participating in flying activities and I agree to refrain from doing so. I hereby confirm that I hold a valid NAC license that allowes me the right to participate at the event and legally perform flying activity within Greece. I further certify that I hold all necessary insurances for my person and flying equipment, inleuding 3th party liability insurance, which is valid in EU and during the dates of the Event.
